CIA ROLE IN THE VIETNAM WAR

David Welker, a CIA historian, delivered a very informative discussion of the CIA's role in the Vietnam War.

The CIA predecessor, the Office of Strategic Services, entered Vietnam during WWII. Its teams trained and led guerrilla operations against the Japanese invaders. The U.S. funded French efforts to eradicate the armed insurgency against French colonial rule from 1946 to 1954. Our policy was to contain the growth of Communism. The French defeat resulted in dividing Vietnam into North and South with an eventual election to unite the country under a single president. At our urging, South Vietnam ignored the election since Ho Chi Minh, a Communist, would likely win. During this time, the CIA conducted Operation Exodus that relocated North Vietnamese Catholics to the South under the pretext that they would be persecuted. As the insurgency increased, the CIA officially returned in 1961. Along with Special Forces, the CIA managed the Strategic Hamlet program that relocated the rural population to fortified villages and armed its villagers. The Gulf of

Tonkin incident in 1964 opened the war to large-scale U.S. and allied military intervention. The CIA role increased too. The Phoenix program monitored and identified VC suspects and interrogated them for intelligence. The Ho Chi Minh supply trail in Cambodia and Laos became a prime CIA area of operations. They trained and armed approximately 40,000 Montagnards to attack the trail. The CIA formed the Air America airline of assorted aircraft to support these operations. A CIA's A-12 Blackbird flew aerial reconnaissance, and ground sensors were deployed to count truck and troop movements on the trail. One of the most successful operations was the establishment of secret communications with our POWs in North Vietnam. Messages were written in invisible ink in family letters. Soaking the letter in water exposed the message. The CIA war successes came with the cost of 36 agents losing their lives.

David Welker's presentation revealed that we should be proud of the CIA for its distinguished national service, but unfortunately, since secrecy is the Agency primary principle, we may never know its true degree of success.

ALL VOLUNTEER ARMY RECRUITMENT CHALLENGES

At the February 15th meeting, Capt. Cole Johnson and SFC Todd Turner discussed the recruitment challenges for maintaining an All Volunteer Army. Capt. Johnson is the commander of recruitment in Virginia, Maryland, and West Virginia. SFC Turner mans the Sterling office.

The current challenge is recovering from the COVID shut down. The standard high school recruitment is now extinct. Many school districts do not allow recruiters in the school and on their property. I can remember the military recruiters conducting an event in my high school for seniors during school hours. I know of at least two seniors joining after the event. SFC Turner provided an example where he was asked to leave the school property where he had set up a table. The quality of new recruits ranging from good to bad was discussed. Drug use is a major obstacle to overcome in light of its pervasiveness in today's society. Trust and accountability are current issues with a potential recruit. Unlike the draft, which involved a medical exam and a minimum background check to be inducted, today's process can take at least 90 days to place the recruit on active duty. The time period allows ample time for a recruit to change one's mind.

Despite these multiple challenges, both expressed optimism and duty dedication in accomplishing their mission. Our country is very fortunate to have such men serving in the military.
